


Friends of Balloons (FOBS)

MEMBERSHIP

Membership of the Friends' scheme is open to anyone who would like to join and is supportive of the charity's objectives.

Within the Friends' scheme, there are a range of ways of supporting Balloons:

1. **Pay a Friends Subscription** - Pay an annual or lifetime membership fee, thereby personally contributing to Balloons fundraising targets, and in return receive Balloons newsletters and updates

2. **Volunteer Fundraising** - Act as a fundraiser for Balloons in a pre-agreed way, e.g. dropping off and collecting Balloons charity pots, running one-off and annual fundraisers, supporting existing Balloons fundraisers such as school fetes, Christmas bazaars etc. by volunteering at those events. Full training will be given to anyone who wants to join our team of volunteer fundraisers

3. **Volunteer Your Skills and Expertise** – volunteer for Balloons in a specific role such as designing service leaflets, proof reading printed materials, advising on website developments, running a free CPD training session for our volunteer Grief Support Workers relevant to the work of Balloons etc. We need different things at different times, and would love to talk to you
